# Historical/Sociopolitical Research

Outhentically writing the Dystopian Hero's Journey 10 points (5 for each annotated source)

**Directions:** We have discussed many times the ways in which dystopian elements sometimes appear in the real world. Today, with my and Mrs. Rinker's help, you will be conducting research to find some specific examples. These will act to inspire your own narrative—writing, thus making it more authentic.

Your task is to create an **annotated bibliography**. Cornell defines an annotated bibliography as follows: *An* **annotated bibliography** is a list of citations to books, articles, and documents. Each citation is followed by a brief (usually about 150 words) descriptive and evaluative paragraph, the **annotation**. The purpose of the **annotation** is to inform the reader of the relevance, accuracy, and quality of the sources cited.

## In this bibliography, you will have...

- At least *two citations* from books, articles, and/or other trustworthy sources. Sources must be cited properly in MLA format. (Google will do this for you: Just listen to Mrs. Rinker!)
- Annotations for each citation describing the way in which this fact/concept you researched will be influencing your narrative-writing. These should be done with proper punctuation and grammar.
  - Honors: Each annotation must be at least 100 words.
  - General: Each annotation must be at least 60 words.

The author of this article, Allison Hahn, explores the brief history of both utopian and dystopian fiction. Utopian fiction is represented by a "perfect," equal, peaceful society, while dystopian literature portrays worlds where many of humankind's hardships and negative natures have been emphasized, creating a society that is unjust and strictly controlled by corrupt governments. The section on dystopian fiction is most useful for my narrative-writing because it conveys many characteristics of a dystopia, such as: controlling governments, gaps between social classes, high technology, brainwashing, censorship, destroyed environments, and propaganda. The world I'm creating in my narrative will definitely be run by a totalitarian government that watches its citizens through technology, specifically tracking those who are becoming dependent on Artificial Technology, and that later starts brainwashing them through such programs.
